## SOFTWARE END USER LICENSE AGREEMENT

IMPORTANT: THIS SOFTWARE END USER LICENSE AGREEMENT ("EULA") IS A LEGAL AGREEMENT BETWEEN YOU AND CARRIER BY AND ON BEHALF OF ITS SUPRA BUSINESS ("CARRIER"). READ IT CAREFULLY BEFORE USING THE SOFTWARE. IT PROVIDES A LICENSE TO USE THE SOFTWARE AND CONTAINS WARRANTY INFORMATION AND LIABILITY DISCLAIMERS AND LIMITATIONS. BY INSTALLING AND USING THE SOFTWARE, YOU ARE CONFIRMING YOUR ACCEPTANCE OF THE SOFTWARE AND AGREEING TO BECOME BOUND BY THE TERMS OF THIS EULA. IF YOU DO NOT AGREE TO BE BOUND BY THESE TERMS, THEN UNINSTALL THE SOFTWARE FROM YOUR DESKTOP COMPUTER.

### 1. Definitions

- (a) "Supra" is a registered trademark of Carrier. All rights reserved.
- (b) "Software" means the Carrier software programs and third-party software programs supplied by Carrier herewith, and corresponding documentation, associated media, printed materials, and on line or electronic documentation.

### 2. License Grants

- (a) You may install and use the Software on a single desktop computer that has a Windows PC operating system (including Windows XP and 7). Otherwise, a license for the Software may not be shared, installed or used concurrently on different computing devices of any kind.
- (b) You may make one copy of the Software in machine-readable form solely for backup purposes. You must reproduce on demand any such copy all copyright notices and any other proprietary legends on the original copy of the Software.
- (c) You agree that Carrier may audit your use of the Software for compliance with these terms at any time, upon reasonable notice.
- (d) Your license rights under this EULA are non-exclusive.

### 3. License Restrictions

- (a) Other than as set forth in Section 2, you may not make or distribute copies of the Software, or electronically transfer the Software from one computing device to another or over a network.
- (b) You may not alter, merge, modify, adapt or translate the Software, or decompile, reverse engineer, disassemble, or otherwise reduce the Software to a human-perceivable form.
- (c) You may not sell, rent, lease, or sublicense the Software.
- (d) You may not modify the Software or create derivative works based upon the Software.
- (e) You may not export the Software into any country prohibited by the United States Export Administration Act and the regulations there under.
- (f) In the event that you fail to comply with this EULA, Carrier may terminate the license and you must destroy all copies of the Software (with all other rights of both parties and all other provisions of this EULA surviving any such termination). In the event a criminal violation is committed in conjunction with a failure to comply with this EULA, Carrier reserves the right to seek criminal penalties.

### 4. Ownership

- (a) The foregoing license gives you a limited license to use the Software. Carrier and the third-party software providers retain all right, title and interest, including all copyright and intellectual property rights, in and to, the Software and all copies thereof. All rights not specifically granted in this EULA, including federal and international copyrights, are reserved by Carrier and the third-party software providers.

### 5. LIMITED WARRANTY

- (a) CARRIER WARRANTS THAT, FOR THE TERM OF THE LICENSE AGREEMENT, LEASE, SUBLEASE, OR OTHER WRITTEN AGREEMENT YOU HAVE ENTERED INTO GIVING YOU THE LEGAL RIGHT TO USE THE SOFTWARE, THE CARRIERSOFTWARE WILL BE FIT FOR ITS INTENDED PURPOSE AS DESCRIBED IN THE APPLICABLE USER'S GUIDE FROM UTC, AND WILL CONFORM IN ALL MATERIAL RESPECTS TO THE SPECIFICATIONS STATED IN SUCH USER'S GUIDE.
- (b) CARRIER DOES NOT WARRANT THAT THE CARRIERSOFTWARE IS ERROR-FREE OR WILL OPERATE WITHOUT INTERRUPTION.
- (c) THE EXCLUSIVE REMEDY FOR NONCONFORMITY OF THE CARRIER SOFTWARE TO THE LIMITED

WARRANTY STATED IN THIS SECTION (SECTION 5) SHALL BE REPAIR OR REPLACEMENT BY CARRIER, IN CARRIER'S SOLE DISCRETION.

- (d) CARRIER DOES NOT WARRANT THE THIRD-PARTY SOFTWARE. YOU SHOULD CONTACT THE THIRD-PARTY SOFTWARE PROVIDER(S) REGARDING ANY WARRANTIES OF SUCH SOFTWARE.

#### 6. WARRANTY DISCLAIMERS

- (a) EXCEPT AS EXPRESSLY STATED IN SECTION 5 ABOVE, CARRIER DISCLAIMS ALL WARRANTIES AND REPRESENTATIONS, WHETHER EXPRESS, IMPLIED, OR OTHERWISE, INCLUDING THE WARRANTIES OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.
- (b) ALSO, THERE IS NO WARRANTY OF NON-INFRINGEMENT AND TITLE OR QUIET ENJOYMENT. NO RIGHTS OR REMEDIES REFERRED TO IN ARTICLE 2A OF THE UNIFORM COMMERCIAL CODE WILL BE CONFERRED ON YOU UNLESS EXPRESSLY GRANTED HEREIN.
- (c) NO ORAL OR WRITTEN INFORMATION OR ADVICE GIVEN BY CARRIER, ITS EMPLOYEES, AGENTS, OR REPRESENTATIVES SHALL CREATE A WARRANTY OR IN ANY WAY INCREASE THE SCOPE OF ANY WARRANTY PROVIDED HEREIN.
- (d) (USA only) SOME STATES DO NOT ALLOW THE EXCLUSION OF IMPLIED WARRANTIES, SO THE ABOVE EXCLUSION MAY NOT APPLY TO YOU. THIS WARRANTY GIVES YOU SPECIFIC LEGAL RIGHTS AND YOU MAY ALSO HAVE OTHER LEGAL RIGHTS THAT VARY FROM STATE TO STATE.

#### 7. LIMITATION OF LIABILITY

- (a) CARRIER SHALL NOT BE LIABLE TO YOU OR ANY THIRD PARTY FOR ANY INDIRECT, SPECIAL, INCIDENTAL, PUNITIVE, COVER OR CONSEQUENTIAL DAMAGES (INCLUDING, BUT NOT LIMITED TO, DAMAGES FOR THE INABILITY TO USE EQUIPMENT OR ACCESS DATA, LOSS OF BUSINESS, LOSS OF PROFITS, BUSINESS INTERRUPTION OR THE LIKE) ARISING OUT OF THE USE OF, OR INABILITY TO USE, THE SOFTWARE REGARDLESS OF THE THEORY OF LIABILITY INCLUDING BREACH OF CONTRACT, BREACH OF WARRANTY, TORT (INCLUDING NEGLIGENCE), PRODUCT LIABILITY OR OTHERWISE, EVEN IF CARRIER OR ITS EMPLOYEES, AGENTS, OR REPRESENTATIVES HAVE BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES AND EVEN IF THE EXCLUSIVE REMEDY SET FORTH ABOVE IS FOUND TO HAVE FAILED OF ITS ESSENTIAL PURPOSE.
- (b) (USA only) SOME STATES DO NOT ALLOW THE LIMITATION OR EXCLUSION OF LIABILITY FOR INCIDENTAL OF CONSEQUENTIAL DAMAGES, SO THE ABOVE LIMITATION OR EXCLUSION MAY NOT APPLY TO YOU AND YOU MAY ALSO HAVE OTHER LEGAL RIGHTS THAT VARY FROM STATE TO STATE.
- (c) THE FOREGOING LIMITATION OF LIABILITY IS INTENDED TO APPLY TO THE WARRANTIES AND DISCLAIMERS ABOVE AND ALL OTHER ASPECTS OF THIS EULA.

#### 8. Basis of Bargain

- (a) The Limited Warranty, Warranty Disclaimers, and Limitation of Liability set forth above are fundamental elements of the basis of the agreement between Carrier and you. Carrier would not be able to provide the Software on an economic basis without such limitations. Such Limited Warranty, Warranty Disclaimers, and Limitation of Liability provisions inure to the benefit of Carrier's licensors.

#### 9. (Outside of the USA) Consumer End Users Only

- (a) The limitations or exclusions of warranties and liability contained in this EULA do not affect or prejudice the statutory rights of a consumer (i.e., a person acquiring goods otherwise than in the course of a business).
- (b) The limitations or exclusions of warranties, remedies or liability contained in this EULA shall apply to you only to the extent such limitations or exclusions are permitted under the laws of the jurisdiction where you are located.

#### 10. Third-Party Software

- (a) The Software may contain third-party software which requires notices and/or additional terms and conditions. Such required third-party software notices and/or additional terms and conditions are available from the third-party software providers, and are made a part of and incorporated by reference into this EULA.

#### 11. General

- (a) This EULA shall be governed by the internal laws of the State of Oregon, without giving effect to principles of conflict of laws. You hereby consent to the exclusive jurisdiction of the American Arbitration Association to resolve any disputes arising under this EULA, with venue to be in Portland, Oregon. In each case, this EULA shall be construed and enforced without regard to the United Nations Convention on the International Sale of Goods.
- (b) This EULA contains the complete agreement between the parties with respect to the subject matter hereof, and supersedes all prior or contemporaneous agreements or understandings, whether oral or written. You agree that any varying or additional terms contained in any purchase order or other written notification or document issued by

you in relation to the Software licensed hereunder shall be of no effect. The failure or delay of Carrier to exercise any of its rights under this EULA or upon any breach of this EULA shall not be deemed a waiver of those rights or of the breach.

- (c) No Carrier employee, agent, or representative is authorized to make any amendment to this EULA.
- (d) If any provision of this Agreement shall be held by a court of competent jurisdiction to be contrary to law, that provision will be enforced to the maximum extent permissible, and the remaining provisions of this Agreement will remain in full force and effect.

This EULA does not authorize you to use Carrier's or its licensors' names or any of their respective trademarks.
